City Council of the City of Benwood met in Regular Session on Tuesday, April 9, 2024 at the City Building in the Council Chambers. Mayor Walter W. Yates called the meeting to order at 7:00 p.m. The following council members were present: Fehr, Ferrera, Givens, Kazemka, Longwell, Lunsford & Mele. Excused absence Councilperson Ankrom. Others present: Chief of Police Frank Longwell, Dave McLaughlin Director of Public Works, Tiffany Ankrom City Clerk & Eric Gordon City Attorney.

6:45 PM PUBLIC HEARING

AN ORDINANCE OF THE CITY OF BENWOOD, WEST VIRGINIA, PROVIDING FOR AN INCREASE IN THE RATES IT CHARGES TO PROVIDE WATER SERVICE.

Randy Watson & Casey Young with THRASHER Engineering and A.C. Wiethe with Belomar Regional were present to discuss the upcoming water project, water rate increase and answer any questions from the public.

A.C. Wiethe discussed the Water Treatment Plant project & the total cost of the project. The project is estimated to cost \$5,000,000 million dollars. The City of Benwood will receive the following grants: \$3,000,000 from Drinking Water Treatment Revolving Fund for Emergent Contaminants 100% Grant, \$1,000,000 Drinking Water Treatment Revolving Fund Debt Forgiveness Grant and a \$1,000,000 grant from West Virginia State Infrastructure all grant funded for a total of \$5,000,000.

The City of Benwood's CPA compiled a financial analysis (Rule 42) and in order for the city to meet its debt obligation & operations it was a necessary to raise the rates. The water rate increase does not have anything to do with the upcoming project but does make the city eligible to receive federal grant funding.

Randy Watson discussed his portion of the Water Treatment Plant project. Where the city's wells are located is where they will be intercepting the main water lines and move the water through large filters that will remove the Iron & Manganese then through units that will remove the PFAS & PFOS also known as forever chemicals. Per Federal Mandate PFAS & PFOS have to be removed from the drinking water whether the city has to pay for it or it is grant funded.

Residents were present to express their concerns raising the water rates.
