## **MINUTES**

Councilperson Kazemka moved to approve the minutes for Special Meeting & Regular Meeting for January 9, 2023 & Councilperson Ankrom seconded the motion. Motion carried unanimously.

#### **NEW BUSINESS**

#### APPROVAL OF PURCHASING RAINY-DAY TREASURY BONDS

Rainy-Day Treasury Bonds and CD's have matured, the interest collected from the investments is \$162,000.

Howard Bertram CFP with WesBanco has CD's available ranging from 4.6-4.8% interest for 1 year. As well as US Treasury Bonds available at 5.35% interest for 6 months.

Katrina Bonar City of Benwood Account Representative with WesBanco offered a Money Market Account with an interest rate of 4.5%.

Councilperson Givens made the motion to invest \$3,174,000 in US Treasury Bonds and Councilperson Lunsford seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

#### APPROVAL OF PURCHASING WATER TREASURY BONDS

Water CD's & Treasury Bonds currently invested are maturing January 26, 2024 & February 22, 2024.

APPROVAL OF ORDINANCE OF THE COUNCIL OF THE CITY OF BENWOOD, WEST VIRGINIA PLACING ON THE BALLOT OF A MUNICIPAL ELECTION DURING THE WEST VIRGINIA PRIMARY ELECTION ON MAY 14, 2024, THE ISSUE OF RENEWING A TAX LEVY FOR THE FISCAL YEAR BEGINNING JULY 1, 2024, AND JULY 1, 2025 TO CONTINUE TO PROVIDE FUNDS FOR THE CITY'S SHARE OF FUNDING FOR ANY DEFICIT OF OPERATING COST AND THE COST OF ACQUIRING CAPITAL, EQUIPMENT AND FACILITIES FOR THE SAME PERIOD FOR A SYSTEM OF URBAN MASS TRANSIT TO BE PROVIDED BY THE OHIO VALLEY REGIONAL TRANSPORTATION AUTHORITY (FIRST READING)

Councilperson Givens made the motion to approve the two-year Tax Levy Ordinance for Ohio Valley Regional Transportation Authority Councilperson Kazemka seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

## **FINANCE & TAXATION**

An ordinance entitled: "An ordinance to pay a claim against the city for work and other claims." Be it ordained by the Council of the City of Benwood, that the sum of \$66,670.29 be appropriated out of the funds belonging to the city, to pay a claim against the city, and that an order signed by the Mayor and Recorder be drawn upon the Treasurer for the above amount and that this ordinance takes effect from and after its passage. Councilperson Longwell moved to adopt the above ordinance on first reading, seconded by Councilperson Kazemka. Mayor Yates called for roll call vote was taken and motion passed unanimously.

Councilperson Longwell moved to adopt the above ordinance on second reading, seconded by Councilperson Lunsford. Mayor Yates called for roll call vote was taken and motion passed unanimously.

## ACCOUNTS PAYABLE CHECK REGISTER REPORTS

Councilperson Longwell moved to receive and file accounts payable check register reports totaling \$66,670.29 seconded by Councilperson Kazemka. Mayor Yates called for a roll call, vote was taken and motion passed unanimously.
