MINUTES

Councilperson Ferrera moved to approve the June 27, 2023 regular meeting minutes & the Special Meeting Minutes for July 14, 2023 and Councilperson Givens seconded the motion. Motion carried unanimously.

PUBLIC COMMENT

Jake Boyd with Benwood Volunteer Fire Department was present to address council to discuss his willingness to work with the city to resolve any issues & answer questions. Some members would like to sell an engine to get personal protection gear and a new thermal energy camera.

NEW BUSINESS

APPROVAL OF WATER/SEWAGE ADJUSTMENTS

Resident at 419 Main Street had a busted pipe in his basement, the water didn't enter the sewer system.

Resident at 4815 Eoff St. had a water line break between the meter & residence. Water did not enter the sewer system.

Councilperson Ferrera made the motion to approve both adjustments according to the ordinance, Councilperson Longwell seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

APPROVAL OF ORDINANCE TO PARTICIPATE IN THE WV MUNICIPAL POLICE OFFICERS & FIREFIGHTERS RETIREMENT SYSTEM (FIRST READING)

Benwood Police Department currently has three officers this would benefit and it would allow the officers to retire at age 50 with 20 years of service. It would save the city .5% in retirement contributions for each officer.

Councilperson Ferrera made the motion to approve the ordinance on first reading and Councilperson Givens seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

DISCUSSION OF GENERAL FUND BUDGET REVISION

APPROVAL OF ORDINANCE OF BACKFLOW PROGRAM (FIRST READING)

In compliance with West Virginia state code 16-1-9, 16-1-9a, 16-1-17, and 16-1-18, the City of Benwood Water Department has implemented these rules and guidelines to help improve our water quality and keep our citizens safe. We will be conducting periodic surveys to evaluate the degree of hazards at each of the businesses in the City of Benwood to determine what backflow protection, if any, is needed.

Councilperson Ferrera made the motion to approve the ordinance on the first reading and Councilperson Longwell seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

OLD BUSINESS

APPROVAL OF AN ORDINANCE OF THE CITY OF BENWOOD, WEST VIRGINIA SETTING FORTH THE TERMS OF A PROPOSED AMENDMENT TO THE CHARTER OF THE CITY OF BENWOOD MAKING THE CHIEF OF POLICE A POSITION APPOINTED BY COUNCIL AND PROVIDING FOR A PUBLIC HEARING ON ITS PROPOSED ADOPTION (SECOND READING)

Councilperson Ferrera moved to receive and file accounts payable check register reports totaling \$128,068.17 seconded by Councilperson Longwell. Mayor Yates called for a roll call, vote was taken and motion passed unanimously.
