#### MINUTES

Councilperson Mele moved to approve the Regular Meeting Minutes for May 28, 2024 & Special Meeting Minutes for May 30, 2024. Councilperson Longwell seconded the motion. Motion carried unanimously.

# **NEW BUSINESS**

### APPROVAL OF 2023-2024 FINAL BUDGET REVISION

Councilperson Kazemka made the motion to pass the final budget revision and Councilperson Mele seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

# APPROVAL OF INCREASED COST ON INVOICE FROM OHIO-WEST VIRGINIA EXCAVATING

Ohio-West Virginia Excavating's estimate was under estimated for the paving on Marshall Street. The increase is \$4,540.23 for a total of \$22,453.05.

APPROVAL OF AN ORDINANCE OF THE CITY OF BENWOOD, WEST VIRGINIA PROVIDING FOR AND APPROVING THE CITY OF BENWOOD ENTERING INTO AN AGREEMENT WITH THE MCMECHEN VOLUNTEER FIRE DEPARTMENT AND THE MARSHALL COUNTY COMMISSION TO PROVIDE EMS SERVICE (SECOND READING)

Agreement between City of Benwood, McMechen Volunteer Fire Department and Marshall County Commission to have a paid ambulance service housed in McMechen. City of Benwood is responsible to pay up to \$74,000 & Marshall County Commission is responsible to pay up to \$68,000 for a period of one year. MVFD shall provide all other funds necessary to provide EMS service for the one-year period. MVFD shall provide paid EMS coverage from 8:00 AM to 8:00 PM as well as per call dispatch of volunteers from 8:00 PM to 8:00 AM 7 days a week, for the cities of Benwood, McMechen and the County.

Councilperson Mele made the motion to pass the ordinance and Councilperson Givens seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

APPROVAL OF AN ORDINANCE OF THE CITY OF BENWOOD, WEST VIRGINIA, PROVIDING FOR AN INCREASE IN THE COMPENSATION PAID TO FULL TIME EMPLOYEES (SECOND READING)

Whereas, in recognition of the hard work and dedication of its employees, Council of the City of Benwood desires to increase the compensation paid to municipal full-time employees.

# APPROVAL OF AN ORDINANCE OF THE COUNCIL OF THE CITY OF BENWOOD, WEST VIRGINIA, PROVIDING FOR AN INCREASE IN THE COMPENSATION PAID TO THE MAYOR (SECOND READING)

The Mayor of the City of Benwood shall receive a raise in compensation of Two Thousand Four Hundred Dollars (\$2,400.00) per year. The yearly salary of the mayor shall thereafter be set at \$14,400.00 per year.

Councilperson Mele made the motion to approve the ordinance and Councilperson Longwell seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.
