City Council of the City of Benwood met in Regular Session on Tuesday, May 28, 2024 at the City Building in the Council Chambers. Mayor Walter W. Yates called the meeting to order at 7:00 p.m. The following council members were present: Ankrom, Fehr, Ferrera, Givens, Kazemka, Lunsford & Mele. Excused absences were Councilperson Longwell. Others present: Dave McLaughlin Director of Public Works, Tiffany Ankrom City Clerk & Eric Gordon City Attorney.

PLEDGE OF ALLEGIANCE

Mayor Walter W. Yates led the pledge of allegiance to the flag.

MINUTES

Councilperson Ferrera moved to approve the Special Meeting Minutes for May 15, 2024 & Special Meeting Minutes for May 22, 2024 & Councilperson Kazemka seconded the motion. Motion carried unanimously.

NEW BUSINESS

APPROVAL OF AN ORDINANCE OF THE CITY OF BENWOOD, WEST VITGINIA PROVIDING FOR AND APPROVING THE CITY OF BENWOOD ENTERING INTO AN AGREEMENT WITH THE MCMECHEN VOLUNTEER FIRE DEPARTMENT AND THE MARSHALL COUNTY COMMISSION TO PROVIDE EMS SERVICE (FIRST READING)

Agreement between City of Benwood, McMechen Volunteer Fire Department and Marshall County Commission to have a paid ambulance service housed in McMechen. City of Benwood is responsible to pay up to \$74,000 & Marshall County Commission is responsible to pay up to \$68,000 for a period of one year. MVFD shall provide all other funds necessary to provide EMS service for the one-year period. MVFD shall provide paid EMS coverage from 8:00 AM to 8:00 PM as well as per call dispatch of volunteers from 8:00 PM to 8:00 AM 7 days a week, for the cities of Benwood, McMechen and the County.

Councilperson Ferrera made the motion to pass the ordinance and Councilperson Mele seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

APPROVAL OF RESOLUTION FOR BASF & PFAS SETTLEMET AS BEING A CLASS ACTION REPRESENTATIVE

The resolution is for a separate set of defendants for the BASF & PFAS settlement.

Councilperson Ferrera made the motion to approve the resolution and Councilperson Givens seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

Whereas, in recognition of the hard work and dedication of its employees, Council of the City of Benwood desires to increase the compensation paid to municipal full-time employees.

Councilperson Ferrera made the motion to approve the ordinance & Councilperson Mele seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed.

APPROVAL OF AN ORDINANCE OF THE COUNCIL OF THE CITY OF BENWOOD, WEST VIRGINIA, PROVIDING FOR AN INCREASE IN THE COMPENSATION PAID TO THE MAYOR (FIRST READING)

The Mayor of the City of Benwood shall receive a raise in compensation of Two Thousand Four Hundred Dollars (\$2,400.00) per year. The yearly salary of the mayor shall thereafter be set at \$14,400.00 per year.

Councilperson Ferrera made the motion to approve the ordinance and Councilperson Lunsford seconded the motion. Mayor Yates called for roll call; vote was taken & motion passed unanimously.

APPROVAL OF POTENTIALLY LEASING OIL & GAS RIGHTS FOR TAX PARCEL ID NUMBER: 13-0006-0005-0000 TO SWN PRODUCTION COMPANY
